**DIRECTOR'S ORDER NUMBER ONE HUNDRED EIGHTY-ONE (2019)**

**VIRGINIA LOTTERY'S "PRINT 'N PLAY ROLLING JACKPOT HOW-TO-PLAY COUPON PROMOTION" FINAL RULES FOR OPERATION.**

In accordance with the authority granted by §§ 2.2-4002B(15) and 58.1-4006A of the *Code of Virginia*, I hereby promulgate the Virginia Lottery's "Print 'n Play Rolling Jackpot How-to-Play Coupon Promotion" ("Promotion") Rules to support the Virginia's Lottery's new *Print 'n Play Rolling Jackpot* Game by encouraging retail visits by players in order to redeem coupon rewards. The Promotion period is August 1, 2019, to October 31, 2019. These rules amplify and conform to the duly adopted Virginia Lottery regulations for the conduct of lottery games.

The rules are available for inspection and copying during normal business hours at the Virginia Lottery headquarters, 600 East Main Street, Richmond, Virginia, and at each of the Virginia Lottery offices. A copy may be requested by mail by writing to: Director's Office, Virginia Lottery, 600 East Main Street, Richmond, Virginia 23219.

This Director's Order becomes effective on August 1, 2019, and shall remain in full force and effect through the end Promotion date unless amended or rescinded by further Director's Order.

**VIRGINIA LOTTERY'S "PRINT 'N PLAY ROLLING JACKPOT HOW-TO-PLAY COUPON PROMOTION"  
OFFICIAL RULES**

- A. PURPOSE:** A Promotion will be conducted to support the Virginia's Lottery's new *Print 'n Play Rolling Jackpot* game by encouraging retail visits by Players in order to redeem Coupon rewards. With this Promotion, Coupons, each redeemable for one (1) free two-dollar (\$2) *Print 'n Play Rolling Jackpot* Ticket, will be awarded.
- B. PROMOTION PERIOD:** This Promotion will begin August 1, 2019, and will end October 31, 2019, ("Promotion Period"), after which all Coupons expire and will hold no cash value.
- C. DEFINITIONS** (for purposes of this Promotion):

"Claimant" means a verified Participant or Player who presents a Ticket that he/she presumes to be a Winning Ticket.

"Coupon" means a digital coupon containing a unique bar code that can be printed and redeemed at retail for the value and product stated thereon prior to the coupon's expiration date. A coupon has no pecuniary or Prize value and shall not constitute evidence of a Ticket purchase or of numbers selected until redeemed.

"Director" means the Executive Director of the Virginia Lottery as established in Chapter 40 of Title 58.1 (§58.1-4000 *et seq.*) of the *Code of Virginia* or any other employee(s) to whom the Executive Director's authority is lawfully delegated.

"Lottery" means the Virginia Lottery.

"Lottery Board" means the group of five (5) people, appointed by the Governor of Virginia, with the power to adopt regulations governing the establishment and operation of the Virginia Lottery and to perform other functions that are set out in the *Code of Virginia*.

"Lottery Retailer", "Lottery Sales Retailer", or "Retailer" means a person licensed by the Virginia Lottery to sell and dispense Virginia Lottery Tickets, materials and games.

"Participant" or "Player" means a Person who is at least eighteen (18) years of age, who makes a qualifying purchase or otherwise validly enters a Promotion according to one of the approved Entry methods stated in the Promotion Rules.

"Person" means a natural person and may not extend to or be applied to a corporation, company, partnership, association or other entity.

"Promotion" means the "added value" offer to consumers or licensed retailers named in the title at the top of Page 1 of these Rules.

"Promotion Rules" or "Rules" means these rules.

August 1, 2019

“Recipient” means a verified Person who is entitled, to receive a Coupon under the rules of a Promotion.

“Self-Service Vending Machine” or “Vending Machine” means an interactive device by which a Player may select a game, purchase a Ticket, and/or receive a Promotion Entry Form, without the help of a clerk at a Virginia Lottery Retailer or an employee at a Virginia Lottery office or other approved location.

“Terminal” means a device that is authorized by the Virginia Lottery to interact with the Virginia Lottery’s central computer system to issue Virginia Lottery Tickets and/or Entry Forms and to enter, receive and process Virginia Lottery transactions that may include issuing Tickets, validating Tickets and Coupons and transmitting reports.

“Ticket” means a game ticket produced by the Lottery’s gaming system and sold by the Lottery for a particular game.

**D. ELIGIBILITY:**

1. This Promotion is open to Players eighteen (18) years of age or older. A Player may be required to provide proof of his/her date of birth.
2. No officer, employee or Board member of the Lottery, or any officer or employee or board member of any vendor to the Lottery of Computer-generated or instant Ticket goods or services working directly on a contract with the Lottery for such goods or services, or any person residing in the same household of any such board member, officer or employee, or any person under the age of eighteen (18) years, shall be eligible to participate in this Promotion. The Lottery will not award a Prize on an Entry submitted by, for, or gifted to or transferred to anyone under eighteen (18) years of age, or to the transferee of such Person.

**E. COUPON AWARD:** To receive a *Print ‘n Play Rolling Jackpot* Coupon, a Player must go to the Lottery’s website at [www.valottery.com](http://www.valottery.com) between August 1, 2019, and October 18, 2019, and:

1. Successfully complete the *Print ‘n Play Rolling Jackpot* How-to-Play interactive learning experience.
2. Complete registration\* or login to a Virginia Lottery MyGameRoom Account.

\*Registration will require entry of a Player’s correct full name [consisting of his/her first name and last name (no initials), date of birth, street address, city, state, ZIP code, last four (4) digits of their Social Security number and telephone number. As part of the Lottery’s registration process for this Promotion, third-party identity authentication will confirm that the Player is eighteen (18) years of age or older. If a Player’s identity cannot be confirmed, additional steps for manual confirmation of identity will be provided.

Upon successful log in, the Player will be provided with one (1) *Print ‘n Play Rolling Jackpot Coupon* to print and redeem for one (1) \$2 *Print ‘n Play Rolling Jackpot Ticket* at a Lottery Retailer or Self-Service Vending Machine at any retail location on or between August 1, 2019, and October 31, 2019.

## F. COUPON REQUIREMENTS:

1. Each Coupon awarded contains a unique single-use redemption barcode and can only be validated at a Lottery Retailer or Self-Service Vending Machine at any retail location during the Promotion Period referenced in **Section B** ("Promotion Period").
2. A Player is only eligible to receive one (1) *Print 'n Play Rolling Jackpot Coupon* during this Promotion.
3. Efforts to redeem a Coupon that has already been redeemed will result in an error message on the Lottery Terminal/Vending Machine.
4. Coupons awarded as part of this Promotion are not transferable, assignable or redeemable for cash.
5. A Coupon will only be offered to Players who completed the requirements specified in **Section E** ("Coupon Award") of these Promotion Rules.
6. Players whose MyGameRoom accounts are rejected during the registration process will not be eligible to receive a promotional Coupon.
7. The Lottery will not mail printed Coupons for this Promotion.
8. Up to 84,434 Coupons will be awarded during this Promotion.

## G. CANCELLATION POLICY:

Canceled Coupon award(s): The Director may, in the Director's sole discretion, cancel the awarding of Coupons on days when conditions make fulfillment of Coupons impractical or inappropriate and may elect to award Coupons at such times and dates, and pursuant to such methods, as the Director may determine, all with the Director's sole discretion. Neither the Lottery, the Director, nor any employee of the Lottery or member of the Lottery Board shall have any liability whatsoever for any such re-schedule or cancellation.

Termination of Promotion: The Director may, at any time, announce a suspension or termination of this Promotion, without advance notice and in the Director's sole discretion, at which point no further Coupons will be generated and no free Tickets shall be awarded. Neither the Lottery, the Director, nor any employee of the Lottery or member of the Lottery Board shall have any liability whatsoever for any such suspension/termination.

## H. DISPUTES: The Director may refrain from awarding/paying a Prize pending final determination under any of the following circumstances:

- if a dispute related to any Prize occurred or if it appears that a dispute may occur;
- if there is any question regarding the identity of the Claimant; or
- if there is any question regarding the validity of any Entry submitted.

No liability for interest arising because of any such delay, or any delay beyond the Lottery's control, shall accrue to the benefit of the Prizewinner pending award/payment of the Prize. The Lottery is neither liable for, nor has it any responsibility to resolve, disputes between or among competing Claimants.

In the event of a dispute or other instance of doubt, the decision of the Director shall be final and binding.

**I. GOVERNING LAW:** By participating in this Promotion, each person agrees to comply with and abide by the Lottery statutes, Lottery regulations, all final decisions of the Director of the Lottery, and these and any other applicable Rules established by the Lottery Board and/or Director of the Lottery for the conduct of this Promotion. Any dispute arising that relates to any aspect of this Promotion shall be governed by the laws of the Commonwealth of Virginia, and the venue for the determination of any such dispute shall be in the city of Richmond, Virginia.

**J. WAIVER OF CLAIMS:** By entering this Promotion, each Recipient agrees to indemnify, hold harmless, and waive any claims against the Lottery and any of the affiliates, employees, directors, officers, agents, representatives and assigns of any of said entities, arising, directly or indirectly, out of, or in any way connected with, this Promotion or the Coupons awarded in connection therewith.

**K. AMERICANS WITH DISABILITIES ACT (“ADA”):**

The Lottery is not responsible for any third party’s compliance with ADA Rules and Regulations where applicable in connection with a Coupon.
